Annex 2 – Conditions consistent with the operating schedule

General – all four licensing objectives

- The number of persons to be admitted shall not exceed 240.
- Entertainment to finish no later than 00.00 Monday to Saturday and 23.00 on Sunday.
- Suitable and sufficient number of portable fire extinguishers must be provided within the Hall and in particular within the vicinity of the stage area and dressing rooms.
- The doors and windows to the licensed area to be kept shut whilst the premises are in use, except in the case of the door, to allow for normal access/egress or in the case of an emergency. The shanks of the barrel bolts on exit doors to be removed and retained by a responsible person during the presence of the public.
- For indoor sports, details must be submitted for the attention of the Environmental Health Services Manager at least 14 days prior to the event.

- The number of persons to be admitted shall not exceed 240.
- A CO2 fire extinguisher is to be kept adjacent to the area designated for entertainment.

The prevention of public nuisance

The shanks of the barrel bolts on exit doors to be removed and retained by a responsible person during the presence of the public.

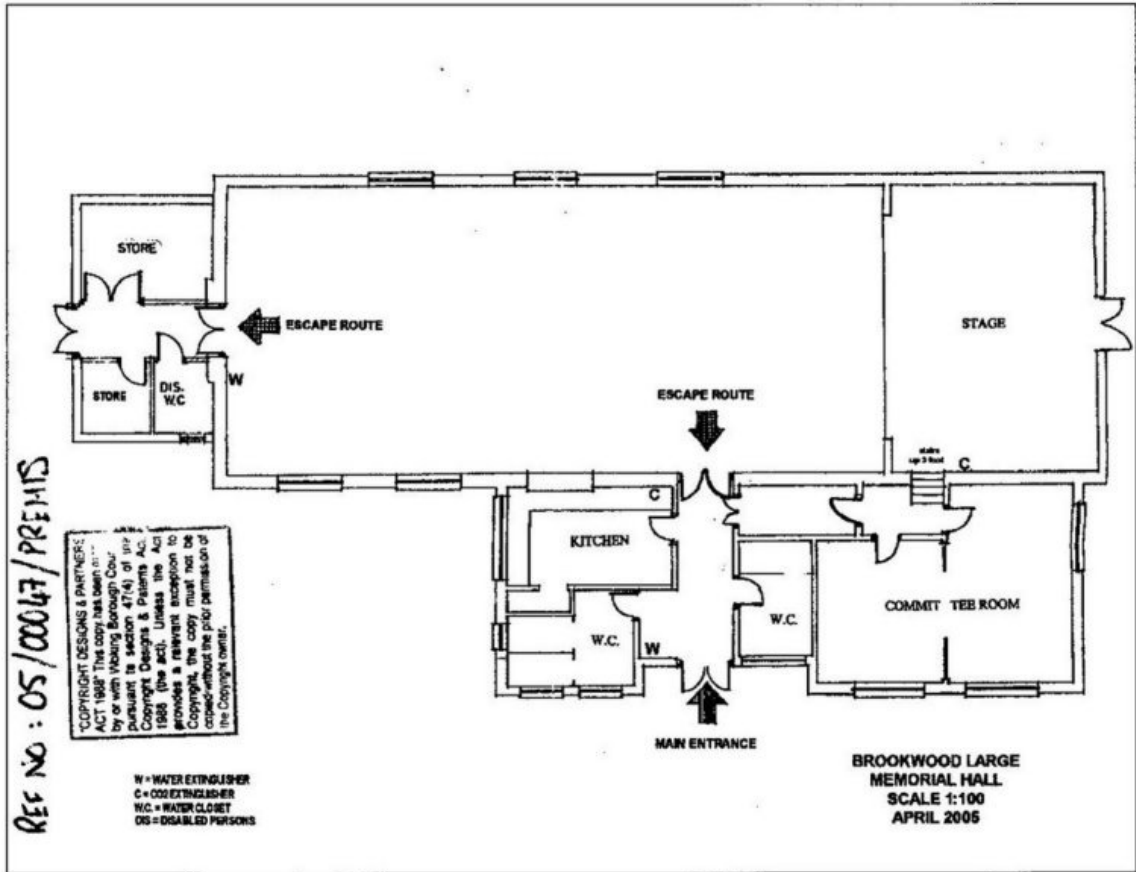
